(1) ~~In addition to operational rules published in accordance with Chapter 120 of the Florida Statutes,~~ ~~T~~he University publishes the University Record Series, as in effect at any particular time, consisting of the Undergraduate Catalog available through the Office of the University Registrar website at <http://www.registrar.ufl.edu/hubstudents.html>, 2004-2005 academic year edition; the Graduate School Catalog available through the Office of the University Registrar website at <http://www.registrar.ufl.edu/hubstudents.html>, 2004-2005 academic year edition; the Levin Holland Law Center College of Law Catalog available through the Levin College of Law website at <http://www.law.ufl.edu/admissions/>, 2005 academic year edition; College of Medicine Information available through the College of Medicine, Office of Admissions website at <http://www.admissions.med.ufl.edu/>, the College of Dentistry Bulletin available through the College of Dentistry website at <http://www.dental.ufl.edu/Offices/Admissions/>, 2004-2005 academic year edition; the College of Veterinary Medicine information brochure entitled "Information for Applicants to the College of Veterinary Medicine" available through the College of Veterinary Medicine website at <http://education.vetmed.ufl.edu/admissions/>, dated July 2004; and the Department of Independent Study Catalog available through the Division of Continuing Education website at <http://www.dce.ufl.edu/>, September 2004. The University Record Series establishes and reflects admission and degree requirements within the University. In addition, the Record contains general information regarding the University and the University community, curricula offerings

and facilities available to students, faculty and staff of the University. The Record also contains the academic calendar as set by the University.

(2) Pursuant to State Board of Education Rule 6A-10.0331, F.A.C., courses which are not taught for five (5) years shall be deleted from the University Record Series except as otherwise provided herein. As part of each year's preparation of the University Record Series, all courses not taught during the preceding five years shall be reviewed by the respective college deans to determine whether those courses should be retained. Courses may be continued if reasonable cause for each course not to have been offered is presented by the appropriate college dean and an expectation that it will be offered is justified to and approved by the Office of the Provost.

(23) Those portions of the Record which are not included in a specific rule published in the Florida Administrative Code are hereby promulgated as the rules of the University. Specific University of Florida regulations Rules published in the Florida Administrative Code take precedence over any conflicting provision of the University Record Series.

(4) Copies of those portions of the University Record Series in which a person is interested can be obtained by writing to the Registrar, University of Florida, Criser Hall, Gainesville, Florida, 32611. Because of the diverse nature of the University, requests should specify that particular portion of the University Record Series in which the inquirer is interested.
