## REGULATIONS OF THE

## UNIVERSITY OF FLORIDA

6C1-3.009 Traffic & Parking; Bus System.

- (1) Transportation and Parking Services supervises the operation of the campus shuttle bus system (including Gator Lift). Use of the campus shuttle bus system is free to all faculty, staff, students, and visitors. Use of the City of Gainesville Regional Transit System is free to all University of Florida students, faculty and staff and their spouses/domestic partners with a valid Gator 1 identification card.
- (2) Effective Fall Semester 201009, a Transportation Access Fee of \$7.336.79 per credit hour is assessed upon all courses and fundable credit hours taken by individuals at the University of Florida. Dental, medical and veterinary students must pay a semi-annual Transportation Access Fee of \$146.60135.80 (One hundred thirty five and 80/100 dollars). Pharmacy students must pay a semi-annual Transportation Access Fee of \$131.94122.22 (One hundred twenty-two and and 22/100-dollars), Physical Therapy students must pay a semi-annual Transportation Access Fee of \$142.93132.40 (One hundred thirty-two and 40/100 dollars), Public Health and Health Professions MPH 2-Year students must pay a semi-annual Transportation Access Fee of \$87.9681.48 (Eighty-one and 48/100 dollars), and Public Health and Health Professions MPH Accelerated Program students must pay a semi-annual Transportation Access Fee of \$79.9671.29 (Seventy-one and 29/100 dollars). This fee is used to help support the on campus shuttle bus system and the City of Gainesville Regional Transit System.
- (3) Students enrolled in a New World School of the Arts degree program in Miami are exempted from paying the Transportation Access Fee. Students enrolled in an off-campus course

shall be assessed all, part, or none of the fee pursuant to the determination of the Office of the Provost based on the location and type of the course.
